8. The City of New Hope is not responsible for damage or loss of materials used or left in the park and does not assume liability on groups or individuals attending a function in the park.
9. Failure to abide by these regulations, the New Hope Park Rules & Regulations, City Ordinances and other City of New Hope Policies may result in the denial of usage of the pavilions in the future.
